To view result, login to our website and go to the result section. Candidate can also view her/his respective OMR Answer Sheet by logging on to the official website of the Board using her/his user name and password as set by the candidate. For viewing OMR Answer Sheet one has to follow the steps given below:

Log on to www.trb.tripura.gov.in → Click on 'Apply Online' link → Click on 'Click Here for UGT-2019, GT(VI-VIII)-2019, STGT-June-2019, STPGT-June-2019' link → Enter user ID and password to log-in and select the test applied for from the left menu in the user home page → Click on 'View Result' → Click on 'View OMR'. Candidates can view their OMR Answer Sheet from 07.08.2019 to 20.08.2019.


Candidates are instructed to remain present on the scheduled date of scrutiny. During scrutiny certificate/mark-sheet of academic and professional qualification including other relevant certificates/documents of the candidates will be examined. Candidates are instructed to bring the following in original and two sets of self attested photocopies during scrutiny:

(1) Downloaded Admit Card and Acknowledgement Page of STPGT/STGT JUNE 2019 (2) Permanent Resident of Tripura Certificate (PRTC) (3) Admit card of matriculation/madhyamik examination as age proof (4) Caste certificate (if applicable) (5) PH certificate (if applicable) (6) Mark-sheets (all semesters/years) of academic qualification (7) Mark-sheets (all semesters/years) of professional (teacher training) qualification (8) Certificates of academic and professional qualification (if any) (9) Photo bearing identity card, like PAN, Voter ID, Passport, AADHAR etc (any one) (10) No-objection certificate from the concerned authority (for in-service candidate) (11) Certificate/ Proof of ESM (for ESM candidate).

STPGT candidates who also appeared in STGT and obtained required marks for scrutiny are instructed to bring four sets of photocopies of required documents (two sets for STPGT & two sets for STGT) for simultaneous scrutiny. Such candidates will attend only on the date of scrutiny as scheduled for STGT, and they will not be required to attend for scrutiny scheduled for STPGT.

IMPORTANT NOTES

- Obtaining cut-off or more marks or having one's certificate scrutinised does not confer any right on any candidate for recruitment, since it depends on fulfilment of conditions of eligibility and number of vacant posts (as per notification).
- Where numbers of candidates obtain cut-off or more marks exceeds the number of vacant posts (as per notification) then a selected number of candidates higher than the numbers of vacant posts are asked for scrutiny of documents. Final selection will be done only on the basis of marks obtained in STPGT/STGT and number of vacant posts (as per notification).
- If a candidate doesn't turn up during scrutiny as per schedule of TRBT or any discrepancy of fact is found during scrutiny; her/his candidature will be cancelled and no further communication will be entertained.
- Your attendance in the process of scrutiny is your approval for the terms and conditions of STGT-June-2019 or/and STPGT-June-2019 as laid down in the respective Prospectus Cum Instructions and other notifications.
